SUPPLEMENTAL DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR MISSION ESTATES

property does hereby desire to extend the scheme of the Declaration to the property known as

MISSION ESTATES, 11TH FILING, an addition to the City of Odessa, Midland County, Texas

and for such property be henceforth governed by said Declaration.

Mission Estates Property Owners' Association formally known as Mission Dorado Property Owner's Association (the "Association") does hereby accept said Property as part of its Association to receive the benefits and be governed by the conditions of said Declaration.

That all of the property owners listed below desire to ratify this Supplemental Declaration to show their desire to be a part of the Declaration and the Association and to be governed thereby.

This Agreement will be executed in any number of counterparts, each of which, when executed and delivered, shall be an original, but such counterparts shall together constitute one and the same instrument.
